Check In: Gate sheets for the day are on the table next to the ring gating.
Please bring your check &/- paper entry if you still owe.

Measuring: See new rules below. Bring your form to the judge to get measured.

Worker Schedule:

Workers make shows possible. This is a small trial and we will all need to work for the day to progress. Please sign up. Workers will receive self-serve raffle tickets. 1 ticket per job. Tickets may be put in a worker raffle, or worth \$1 each at our vendors. (Food, & K9 Massage)

Mulligan runs will be available Saturday only. \$5 payable by cash/check, PayPal, or Venmo. Dog **MUST be entered in that class** to run a mulligan. Please write your name on the board.

Crating Indoor crating may be available in the FRONT HALF of the barn aisle ONLY.

Bathroom Facilities

There are porta-potties outside at the top right corner of the barn with sanitizer.
There is a sink for hand washing located in the wash stall inside the barn.

NFC Food Reward Area

This trial will allow use of a food reward area for NFC runs. This area will be closed off during all other runs. Please see section 4.12a, page 35 of the UKI Rule Book for complete details.

Walk Throughs: 8 minutes, then 5 minutes to first dog on-the-line.

Trial documents: maps, run orders, maps, results & ribbons

Run orders, maps and results will be emailed and posted on-site, and on MyDogEntry.com

Course maps will be emailed when doors open. No paper copies will be available.

Class ribbons are self-serve. If you earned a title please let us know to make your ribbon!

Leashes:

Dogs may run “naked” or with ONE flat buckle collar with nothing attached. A Seresto collar counts as your one collar. No martingales. You MAY NOT run with your leash in your pocket.

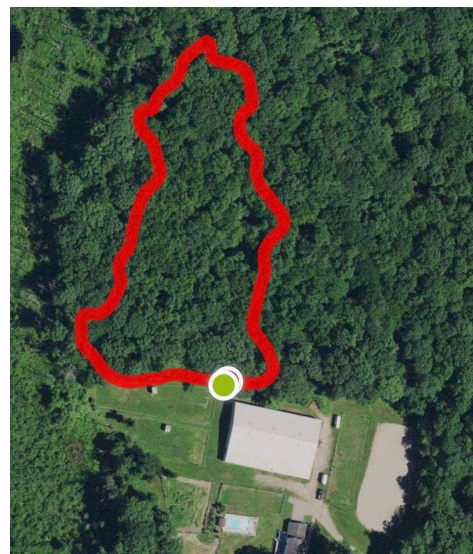

Dog Potty Areas

Dogs may be walked on-leash around the top of the property to the right of the driveway.

There is a designated **off-leash “poop loop”** walking trail accessible behind the arena. ~10 minutes at a brisk pace. If your dog is uncomfortable around unleashed dogs, the front of the property is a better choice.

Please watch that your dogs do not mark in the barn or arena! There will be a bucket near the door for depositing poop bags. Exhibitors are responsible for cleaning up after their dog(s).



Measuring dogs. Please complete the form on the next page and bring to the judge.

New measuring rules as of September 2024.

Measuring Dogs All registered dogs are measured free of charge. All trials must have an official measuring device by their second trial. All newly registered dogs or a dog without a permanent measure, not jumping full height (24", 22", 20" select) must be measured by a UKI judge or approved UKI measurer to determine the dog's jump height.

All handlers are solely responsible for the behavior of their dogs including during measuring. If there is doubt as to how a dog will react towards the measurer, the dog will need to wear a muzzle while being measured. Handlers must prevent any aggressive behavior during measuring.

A 1st measurement must be obtained and sent to the UKI office by the dog's 3rd trial. A measurement from another organization may be used for this first measure if it is an actual measurement and is not within .25" (6mm) of a jump height cut off. A 2nd measure must be obtained between 12 months and by a maximum of 18 months after the dog's first recorded measurement. If this timeframe is not met, the dog is unable to compete at any UKI event until this is done.

If a newly registered dog is aged three years and older, the dog will only need one measurement, and this must be by a UKI measurer. No other organization's measure may be used for this. If a dog is found to have achieved results when it has not complied with the measurement rules, all results that have been gained while breaking these rules will be void and any progression will be rescinded. Dogs will be measured using official measuring devices while the dog is placed in a standing stacked position on a flat surface such as a table. The measurement is taken from the perpendicular line from the highest point at the top of the dog's withers to the flat surface. At the time of measuring, the measurement will be recorded and sent to the UKI office.

If there is a controversy over the dog's permanent measurement, then the owner/handler may ask for an appointed UKI official to re-measure the dog's height. If this 3rd measure agrees with the permanent measurement, keeping them in the same height category, the handler may not challenge their permanent measure again. If the 3rd measure does not agree with the current jump height category, a 4th measure must be obtained. If available, this should be at the same trial but by a different UKI measurer. If the 4th measure cannot be done on the same day as the 3rd, then the dog must stay at the current jump height listed on their UKI account until this last measurement is obtained. This 4th measure will be the deciding factor. No further challenges will be accepted, including those where another organization has measured differently.

If a handler disputes their dog's first or permanent measurement, the dog may be re-measured by a different UKI measuring official as a challenge measure. The handler is responsible for communicating to the show manager that they require a challenge measure and the show management must record this as such. If this challenge measurement confirms the original result, it stays final and no further challenges will be permitted for that measurement. If the challenge measurement does not confirm the original result, a second challenge measurement must be obtained. This should be completed at the same trial but by a different measurer; otherwise, the dog must continue competing at its current jump height until their next UKI trial, where the second challenge measurement must be taken. This second challenge measurement is final. All challenge measurements must be clearly documented by the show management and sent to UKI which will record the results to ensure that no additional challenges are permitted.

Dogs may always jump higher than their height category. Dogs who are competing at 22 inch, 24 inch or 20 inch Select do not need to be measured.

- Any dog who does not have a permanent measure on their UKI account must follow these rules.
- A 1st measure must be obtained and sent to the UKI office by the dog's 3rd trial. A measurement from another organization may be used for this measure if it is an actual measurement and is not within .25" (6mm) of a jump height cut off.
- A 2nd measure must be obtained between 12 months and by a maximum of 18 months after the dog's 1st recorded measurement.
- If the dog is age three or over, the dog will only need one measure, and this must be taken by a UKI measurer.
- In summary, to receive a permanent jump height measurement: If the 1st measure is on a dog under 3 years old, the dog must be measured by a UKI official 12-18 months after their 1st measurement or the dog is a minimum of three years old at their 1st measure.

Training-in-the-ring options.

4.12 Not For Competition

- A handler may choose to participate in any class they are eligible to compete in as “not for competition” (NFC). This must be stated in advance to the run and noted on the Scribe sheet with NFC. This will allow the handler to use the standard course time to train and practice the course.
- The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him.
- If a handler chooses to participate in a class for NFC, he/she may use a toy or other like training device for rewarding their dog’s performance. They may also choose to have another person assist them in the ring during their course time. Targets are allowed as long as they are not placed on any piece of equipment and no additional time is taken to place or remove these. Handlers may not alter equipment in any way by putting something on it, under it or over it.
- No audible training aids or audible toys will be allowed. No food is allowed in the ring.
- A dog & handler may not leave the ring boundary for the purposes of rewarding the dog outside the ring in any manner, except for a designated area detailed in 4.12a (not available at this trial). Should a handler choose to leave the ring at any time to reward their dog, the run ceases and they may not return back into the ring.
- The judge shall not judge the dog, but shall continue to watch the handler to ensure safety, good judgment and fair treatment of the dog. Handlers may not ask the judge or any ring party to leave the ring.
- If a handler does not state NFC and the judge deems them to be training, they will be eliminated.
- A dog may NOT run NFC in a Level they are not eligible for. A dog may jump lower in the Select Height than they measure only for NFC, but the handler must contact the Show Manager to notify them of this wish before the show. If they opt for this, the dog may not also enter their competition height in those classes. The purpose of this is for dog’s who may be recovering from injury or for other reasons are unable to jump their Select option height.

4.12 Not For Competition

- A food reward area may be available, which is set adjacent to the ring boundary for the purpose of giving food to a dog during an NFC run.
- This option is not allowed for Masters Series Heats, Tournament classes, Cups, Classics and Opens.

4.13 Repeat and Move-on “RMO”

- During a run, a competitor may immediately repeat any obstacle one time at the competitor’s discretion. This is an immediate elimination.
- In so doing, the competitor may repeat one or a maximum of two relevant preceding obstacle(s) prior to the point of error if it is beneficial to their performance of the obstacle. If the error is a knocked bar, a competitor may reset a maximum of 1 jump bar.
- The handler can either continue to work the remainder of the course in normal competitive spirit or immediately head to the exit of the ring.
- If a handler attempts to repeat another obstacle or the judge deems that the handler is continuing to train on the remainder of the course, the judge must immediately dismiss the handler and the competitor must go to the exit of the ring.
- It is strictly understood by competitors that no harsh punitive correction shall be used at any time during their attendance at a UKI event and this is also including RMO.
