DIRECTIONS TO LINCOLN SPORTS FOUNDATION (FKA: ABBOT SPORTS COMPLEX):

From the North, East and West: Exit I-80 at Exit 405 (US-77N/56th St). Turn towards Lincoln (right if coming from the west; left if from the east). Onto N 56th St. In 0.2 miles, turn left onto Arbor Rd, then in 1 mile turn right onto N 70th St. The Sports complex is 0.4 miles on the left.

Alternate route: continue on N 56th St until road T's at Hwy6/Cornhusker Hwy. Turn left and in 1 mile turn left again at the light onto N 70th St. In 1.3 miles, complex is on the right.

From the South: Take NE Hwy 2 or Nebraska Parkway to 84th Street. Turn north onto 84th street and continue 10/13 miles until 84th St T's at Hwy 6. Turn left and travel 1 mile taking the overpass. Turn right at the light onto N 70th St. In 1.3 miles, complex is on the right.

Check in with MyDogEntry.com (MDE):

MDE will be used for paperless check-in, maps and gate stewarding. Instructions for how to use MDE are on the homepage. The day before the trial, there will be buttons at the top of the home page for checking in, maps and running order. The simplest way to check-in is to first log into your account (everyone enters has one). Then click on the Check In button and just your dogs' check in info will appear. You can also check in without logging in, you just have to look through all of the dogs. Choose one of the 4 options: check-in, scratch, FEO or conflict (note: MDE optimizes the running order to maximize distance between dogs for handlers with multiple dogs). If you indicate conflict, the Gate Steward will have the ability to move the dogs. As dogs go to the line to run, the Gate Steward will call out the dog's name and then mark the dog as having run when they are finished. The dog's name at the top of the run order should be the dog currently running

If you don't have a smart device ask your crating neighbor or see me for help. Also, we plan to have two monitors set up showing the current run order; one near the ring and one in the crating area

Be aware that although a paper copy of the running order will be posted the Gate Steward will be using the MDE version.

Move-ups:

Move-ups for Saturday and Sunday will be accepted in person by close of trial the night before. I'll have the forms...sigh... on my table.

Armbands and Measuring:

Armbands will NOT be used by GLOC for this trial. The judge **IS NOT A VMO** and will only be measuring dogs that do not have official measurements.

THE TRIAL CAN'T HAPPEN WITHOUT VOLUNTEERS!
A signup sheet will be posted in the ring area.

Trial Site:

Trial site will be open at 7 a.m. Friday, Saturday and Sunday. We will unload the truck, lay tarps in the crating area and preset the rings Thursday night at 6pm. **Early crating will be available for those who help.** The crating area will be available for everyone at 7 am Friday. This trial will be held indoors on soccer turf. The building is air conditioned. Crating is available in room adjacent (shares wall) to the trial on track and field workout area. Certain areas will be cordoned off. **Please respect areas designated do not enter** in the crating area and ensure your dogs do also. Bring matting, chairs, crates, and clean up tools. **If you have clean tarps, please bring** as all the turf in the crating area must be covered. Water is available on site. Dogs must be removed from the trial site upon completion of the trial each evening. In addition, dogs and personal supplies must be **off the workout area by 5pm on Sunday.** **All dogs** must be on leash at all times when not in the ring or in the designated warm-up area. **Please** clean up after your dog(s)! No ex-pens will be permitted inside the building. Ok. Lecture is over.

Food:

There is no potluck offered this time. Sorry for the inconvenience. Concessions will be available on site; also, fast food restaurants are within 5 minutes of the trial site (McDonald's, 5327 Cornhusker Hwy; Casey's, 5500 Superior St, and Casey's 4335 N 70th St) along with restaurants on Havelock Ave.

Lodging: These motels will accept guests with well-mannered dogs. Please check motel policies before making reservations. There may be an additional charge.
