Thank you for coming out and supporting Canine Sports & Games as we host our first trial at Ann Arbor Dog Training Club. **Show site opens at 7:30 AM to exhibitors. Trial Staff will be setting before then – Please be respectful and don't enter the building until 7:30.** There will be no early entry other than the set-up crew. Day of show entries will be taken between 7:30 and 8:00 AM. Measuring will take place at 8:00 AM and throughout the day as needed. The judge's briefing and first walk through will immediately follow morning measuring. We aim to start the walk through at 8:15 am each day.

12/12, 35C/35C

*The Double Down (DD) classes of Jackpot and Jumpers will run back-to-back for each level.

Day Of Show Entries: The trial did not fill and we will be taking DOS entries both days. To speed the process and minimize contact at the trial secretary table, please consider emailing your entry in advance to csgagility@gmail.com

Note: Any entries submitted after closing are subject to an additional \$2.00 per run fee and package discounts do not apply. **Thanks to everyone who entered prior to the closing date.**

Crating: There is no Thursday night set-up. We should have adequate space for all exhibitors to crate in the performance building. The building is air conditioned/heated. Exhibitors are welcome to crate from their cars or bring pop-ups to set up on the grassy area at the west end of the parking lot. No pop-ups inside the fenced area around the pond or on the grassy area at the east end of the parking lot.

Measuring: Dogs without a permanent jump height card will be measured before the judge's briefing and throughout the day as needed. A height card with an actual measurement from another agility venue may now be used in lieu of a measurement at a CPE trial.

Dogs: Dogs are to be crated or held on leash at all times, other than in the ring or at the practice jump. Dogs MUST leave the ring on lead. DO NOT allow your dog to run out of the ring. Please monitor your dogs; dogs that bark constantly make it difficult for the scribe to hear the judge.

Please clean up after your dogs at the show site and where you have overnight accommodations. Please use the receptacles outside for waste.

Course Maps: Will be posted to the My Dog Entry website by 4:00 p.m. the day before each trial day. Course maps will also be posted in the performance building. Exhibitors are encouraged to take a picture with their mobile device. No paper copies will be available.

General Briefing & Walk Throughs: The general briefing each morning and before each class will be short. Walk throughs will be broken down by jump height and kept small to minimize the number of people in the ring. Each walk through will be 5 minutes long. If the walk through is split into two or more groups, there will be no 5-minute wait period between the last walk through and the first dog on the line. Be prepared to run immediately after the last walk through has been completed.

Judge's Class Briefings: The judge's briefing will be included on each course map. The judge will specify a location to answer questions during each walk through.

Course Builders & Ring Crew: Our chief course builder is Linda Karalambo. Please see Linda if you are willing to help course build. If you would like to work, please see the sign up sheet on My Dog Entry.

Leashes: All handlers have the choice to put their leash in their pocket or safely loop it around their waist or neck, it does not have to be out of the dog's sight; however, if the dog interacts with it during the run, it would be considered a toy and result in an NT.

Banda Bucks: Banda Bucks that you earned at previous Banda trials will be honored for the rest of 2026 by Canine Sports & Games.

CSG Worker Bucks: For each class you work, you will receive a dollar off a future Canine Sports & Games entry. Keep track and at the end of the day or weekend, see the Club Member identified for your bucks. Each day a Club Member will be identified as the Worker Contact.

Results: Results will be posted at the end of each run as usual; they will also be emailed on Sunday evening at the end of the trial. Labels will be printed and available at the ribbon table. If you have a question about your score, please see someone at the secretary's table immediately. Changes cannot be made to your score after the day ends.

Ribbons: Ribbons are self-serve. And will be at a table in the back of the room. Teal is for placement Qs for levels 1-5. The Rainbow ribbons are for Level C Qs only. Placements are for qualifying runs.

Titles: If you are running for a title, please let the trial secretary know in advance the class/day/title and number (C-ATCH 1, C-ATE 2., etc.), We want to make sure we have sufficient supplies of title ribbons on hand for all. Or complete our title form posted on the My Dog Entry site.

Move Ups: We will accept day-to-day move ups. Move up forms will be available at the trial secretary's table.

Food: Lunch and water will be provided at this trial for workers. After the Judge, Course Builders and Workers eat, anything left over will be available for non-workers for a small donation. You, of course, may bring your own food/water or have it delivered.

No alcoholic beverages will be allowed on the property and smokers should smoke in their vehicles and keep cigarette butts in their vehicles.

Vendor: Fun Time Dog Shop will be on the premises Saturday and Sunday.

Potty your dogs: AADTC has strict rules for cleaning the turf. Please make every effort to potty your dogs appropriately before your runs. Stopping to clean up delays the trial a minimum of 15 minutes each incident. Your fellow exhibitors will thank you! 😊

DIRECTIONS TO THE SHOW SITE:

From Lansing: I-96 east to US-23 South to North Territorial Rd (exit 49). Follow the roundabout to East North Territorial (third exit). Exit Roundabout 1.1 miles to Hoban Way. Turn left 0.2 miles to show site.

From Toledo or Ann Arbor: US-23 North to North Territorial Rd (exit 49). Follow the roundabout to East North Territorial (first exit). Exit Roundabout 1.1 miles to Hoban Way. Turn left 0.2 miles to show site.

From Detroit: I-96 east to M-14 east to Gotfredson Rd (exit 15). Turn right to North Territorial. Left on North Territorial approximately 8 miles to Hoban Way (turn right) just past Nollar Rd. before railroad tracks. 0.2 mile on Hoban Way to show site.
