

ARF January/ February 2026 Final Confirmation Letter

Thank you for your entry into the **ARF Speedway** trial to be held on **January 31-February 1, 2026**, at Agility and Rally for Fun, located at 659 Eastgate Parkway, Gahanna, Ohio 43230. Please read through the following Final Confirmation for **important information**.

WORKERS: **PLEASE sign up to work.** This helps the trial run smoother and quicker if we have sufficient volunteers. A \$1 coupon towards future ARF trials is provided each time you work. If you want to learn a job, we will be happy to teach you! **Please pay attention to when you work and show up on time.** Use the online sign-up sheet located here: **ARF JANUARY WORKER SIGN-UP** *Please note if you sign up to be a Course Marshal you must have completed the training provided by CPE

PARKING/BUILDING INFORMATION: Parking spots located in the front of the building are reserved for ONLY handicapped, trial committee, and photographer. All exhibitors should park at the rear of the building. **NOTE: Parking directly against the ARF building in the back is reserved for people who are crating in their cars.**

SET-UP/TIMES/BRIEFING: We will be offering early set up from 5:15 PM- 5:45 PM Friday evening (1/30). The building will be open both days, Saturday and Sunday, starting at **8:00AM**. General briefing will begin at **8:45 AM** and walk-thrus for the first class will immediately follow. There will be 5 minutes between the end of walk-thrus and the first dog on the line unless there are three or more dogs ready to run before those five minutes are up.

RUNNING ORDER: Will be sent to all exhibitors the week of the trial but is subject to change with day of show entries being accepted.

COURSE MAPS: Full size course maps will be posted at the site each day.

CRATING: Everyone is required to have a waterproof mat/tarp underneath their crates. Please consolidate your space as much as possible.

GATE STEWARD & CHECK-IN: Please check your dog in before each class. Check-In/ Run order will be posted near the ring entrance.

WALK THRUS: The walk time will be reduced to 5-minute walks.

COLLARS/ LEASHES: Dogs can now run with or without a collar. Collars should preferably be quick release style, a flat buckle, rolled leather, or flea prevention. No attachments of any kind are allowed on the collar. All handlers have the choice to put their leash in their pocket, safety loop around neck or waist, or drop it at the start line.

LEASH BOXES: This trial uses leash boxes. When you have completed your run, please immediately enter the leash box with your dog and leash your dog **after** you are in the box. This allows for the next dog to begin their run while you are still leashing your dog and speeds up overall time for the trial.

RESULTS: Results will be posted on the wall. Please take a picture and move on. Do not crowd or linger around results. This includes both paper results and the monitor.

RIBBONS: Run result labels will be placed on Q ribbons, matched with respective placement ribbon, and laid on tables for exhibitors to pick up. If you choose not to take the ribbons, there will be a box for you to place unwanted Q and placement ribbons in.

FOOD: No food will be provided at this trial. See below for many restaurants nearby that offer delivery or take out options!

Please pick up after your dogs, both at the trial and hotels. Bags and collection buckets are located at both the front and rear entrances. Potty areas are in the grassy areas across the street and the area to the left of the building at the end of the sidewalk. **DO NOT walk your dog on the grass in front of the other businesses.** All dogs MUST be always on a leash and under handler control, except in the ring. No electronic collars are permitted anywhere on the trial site.

Please wipe your feet and your dog's paws when entering the building. Please use the rags located at each entrance to clean both dog paws and human feet!

DIRECTIONS TO AGILITY AND RALLY FOR FUN (ARF)

659 EASTGATE PARKWAY, GAHANNA, OH 43230

FROM THE NORTH:

Take I-270S on the east side of Columbus towards Gahanna

EXIT at HAMILTON RD; turn LEFT

Turn RIGHT on MORRISON RD (2nd traffic light)

Turn LEFT on TAYLOR RD (2nd traffic light)

Continue to follow TAYLOR RD through the traffic light at Taylor Station Rd

Turn RIGHT on EASTGATE PKWY

- This is the point on Taylor Rd where a curved road sign is present

ARF is the first entrance on the RIGHT

- The building is located in the front, left of the complex
- There is an awning on the building marked "AGILITY AND RALLY FOR FUN"
- Parking is available in front of the building (except for trials), in front of the adjacent building, or behind the buildings
- DURING TRIALS: Parking in front of the building is reserved for handicapped, trial committee, judge, and photographer

FROM THE SOUTH:

Take I-270N on the east side of Columbus towards Reynoldsburg/Gahanna

EXIT at E BROAD ST; turn RIGHT

IMMEDIATELY merge to left lane and turn LEFT on TAYLOR STATION RD (1st traffic light)

Turn RIGHT on TAYLOR RD (4th traffic light)


Turn RIGHT on EASTGATE PKWY
