Thank you for entering the January 31-February 1, 2026 Paws 'N Effect CPE Agility Trial. There are approximately 202 runs on Saturday and 200 runs on Sunday. Please help us keep the trial moving by being ready for your runs and for your volunteer assignments. **-We thank everyone in advance and hope you have a great weekend! THANK YOU FOR VOLUNTEERING!**

IMPORTANT NOTES

We appreciate your cooperation in protecting our new Field Turf by adhering to the following rules:

- Chairs and tables must be placed on the hard floor perimeter of the ring.
- Do not drag any of the obstacles on the floor – they must be lifted to move them.
- Only soft-soled shoes are allowed. Your shoes must be clean and dry. During inclement weather, please change footwear before running dogs. Check your shoes each time you come in the building to be sure you did not step in a neglected poop!
- THE USE OF ANTI-SLIP SPRAY OR WAX IS STRICTLY PROHIBITED
- Make sure you walk your dog before each run.
- If your dog eliminates in the ring, gather them up immediately so they stay in one spot. Urine must be blotted immediately with microfiber towels that are located on the windowsill around the room as well as in the basket on the floor. DO NOT USE PAPER TOWELS ON THE TURF.
- There will be a \$20 cash fee for every dog elimination on the turf.
- On Saturday & Sunday you can arrive at 7:00 am. Measuring takes place at 7:30 – 7:45 am and the 1st dog on the line at 8:00 am. The judge will be available to answer any questions. All doors and gates will be clearly marked.
- **Parking:** If you are crating in Little Paws, please unload and park away from the buildings. Please leave parking spaces nearest the building for exhibitors working from their cars. Handicapped spaces are available on first come basis. **There is no overnight RV parking.**
- **Crating Space:** Crating spaces in Little Paws are available on a first come, first serve basis. Please put a mat under your crates. Crating is also available in the outdoor ring and you are welcome to bring a shade tent/pop up.
- No food or drinks will be available at this trial so please bring whatever you need for both you & your dog.
- **COURSE MAPS:** Will be posted to mydogentry.com at 3PM the day before they are to be run. **Please remember the judge may make subtle changes on the field if she feels something lays out unsafely.**
The run order and maps will be posted in Little Paws for you to put on your phone. The Gate Steward will invite you into the building. Please wait until you are asked to come in.
- Scores will be posted in Little Paws. Qualifying & placement ribbons will be self-serve in Little Paws. Please let us know if you maybe up for those all-important titles CATCHs, CATEs, and Championships.

- **MOVE-UPS:** Dogs able to move up after the closing date may do so by providing written notice to the Trial Secretary, Bonnie Collins, **prior to Noon on Monday, January 26, 2026** Move-ups from Saturday's Colors, Snooker and Standard to Sunday must be submitted to Secretary at the end of class on Saturday. There are no same day move ups. Thank you for your co-operation

IT IS ABSOLUTELY REQUIRED THAT YOU PICK UP AFTER YOUR DOGS. Failure to do so will result in you being excused from the trial.

DIRECTIONS:

Paws 'N' Effect, 36 Corporate Ridge, Hamden, CT 06514

From I-91: – Take exit 10 (Rt 40) to end. Right onto Rt 10 (Whitney Ave) approx 1 mi. to left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From Rt. 15: South: Exit 62 to Whitney Ave. north. Continue on Whitney Ave (Rt 10 North) for approximately 3 mile. Turn left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From Rt 15: North: Exit 60 (Dixwell Ave). Left at end of ramp – go to intersection with Rt 10 (Hamden Town Hall on left). Turn left onto Rt 10 (Whitney Ave north). Go 2.1 miles to Sherman Ave. Turn left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.

From I-84: Exit onto Rt 691, then 1st exit onto Rt. 10. Follow through Cheshire into Hamden and take right onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill.
