**Arriving and setup at Bratty Paws:**

- Bratty Paws is located on a 10-acre site with plenty of parking.
- You can crate indoors. Please try to consolidate your area to allow ample space for others.
- We also encourage you to bring your canopy, sun shades, chairs and battery fans for use outdoors and set up on a grassy location on the property.
- As an option, you are welcome to work out of your vehicle; however, if you are running your vehicle, it needs to be away from other people and dogs and on the pavement.
- We are asking all of our exhibitors RV'ing at Bratty Paws to work out of your RV

**MY DOG ENTRY:**

- We will be using [MyDogEntry](#) (MDE) at this trial. You can access MDE at <https://mydogentry.com/> When you first visit [MyDogEntry](#) your phone may offer to install MDE. Just allow the installation and an MDE icon should appear on your home screen.

Features of MDE for our exhibitors:

- You will be able to create a trial entry in MDE and either print/mail the entry to the Trial Secretary with your check or complete/pay online (before trial closing).
- All of the Trial Maps will be loaded into MDE.
- You will be able to check in using MDE.
- Run Orders will be tracked and updated real time on MDE (similar to Agility Gate, but with estimated run times).
- You can receive the results of each class as it is completed.
- Make sure you sign up for Text Alerts!!

### **Checking In on MDE:**

Each morning of this trial there will be a large "Check-In" button at the top of the MyDogEntry screen.

- If you are logged in to your MyDogEntry account when you click "Check-In", you'll see a list of your dogs and can check-in for each class.
- If you are not logged in to your MyDogEntry account when you click "Check-In", you'll see a list of trial locations. Click on your trial location and you'll see a list of all dogs. Scroll down to find your dog's name. Click on your dog and check-in for each class.
- This can be done using your home computer, tablet, or mobile phone.

Each morning of this trial there will also be a large "Run Order" button at the top of the MyDogEntry screen.

- If you are logged in to your MyDogEntry account when you click "Run Order", you'll see the current run order and your dog will be highlighted in green.
- If you are not logged in to your MyDogEntry account when you click "Run Order", you'll see a list of trial locations. Click on your trial location to see the current run order.
- The dog shown at the top of the screen is either currently running or will run next.
- The estimated run times will update automatically throughout the day.
- This can be done using your home computer, tablet, or mobile phone.

### **Other items for the trial:**

- The volunteer worker sheet will be posted at the trial. We need your help!! All volunteers will receive tickets for a daily raffle.
- Maps will be posted to MDE after 6PM the evening before each trial day. Maps will be posted outside the building on a bulletin board, feel to take a picture with your phone.
- The retail store is open, and you are welcome to buy and browse.
- Results will be posted in the building. At the end of the trial, results will be emailed to each exhibitor.
- There will be no food provided at the trial, please bring your own. Water will be available for workers.
