Colors – 12, 35C
Wildcard – 12, 35C
Jumpers- 12, 35C

Site Information:

- ❖ The building will open at 7:00 AM both Saturday and Sunday.
- ❖ Please Park in the designated area. There is to be no parking or unloading in front of the building.
- ❖ Only clean shoes are allowed on the turf. It's Springtime, please bring footwear to wear outside.
- ❖ Please bring a crate pad or tarp to place under your crate(s).
- ❖ **Clean Up After Your Dog!** Please place waste in the OUTSIDE receptacles provided.
- ❖ **Do not allow dogs to urinate on/near the building or trash containers.** Potty your dog(s) in the specified area on the North side of the building.
- ❖ Dogs must always be on leash (inside and outside) unless they are in the ring or at the warm-up jump.
- ❖ Bitches in season are not allowed on the premises.
