**NOTICE TO EXHIBITORS**

- \*The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- \*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.
- \*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.
- \*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Right onto Rt 10 (Whitney Ave) approx 1 mi. to left onto Sherman Ave at Dunkin Donuts. 8/10 mi to right onto Corporate Ridge. Bldg to left at top of hill</p> <p><b><u>Rt 15 south</u></b> – Take exit 62 (Whitney Ave. north). Right onto Whitney Ave and follow as above.</p> <p><b><u>Rt 15 north</u></b> – Exit 60 (Dixwell Ave) Left onto Dixwell, then left onto Rt 10 north. Go 2.1 mi to Sherman Ave and follow as above.</p> <p><b><u>I-84</u></b> – Exit to I-691, first exit onto Rt 10 south. Through Cheshire into Hamden to right onto Sherman Ave and follow as above.</p>
