Directions: I-87 to Exit 31. NY 9N North to Elizabethtown. Turn right at the stop light, take the next right onto Route 8. Elizabethtown Fish & Game Club is about 1.1 miles ahead on the left.

From VERMONT. VIA Crown Point Bridge, route 185 to NY 9N (north), through Westport to Elizabethtown, approx. 8 miles. Turn right at the stop light, take the next right onto Route 8. Elizabeth Fish & Game Club is about 1.1 miles ahead on the left.

VIA Charlotte/ Essex Ferry. Follow Rte 22 South to Wadhams. Make a slight right onto Route 8. Elizabethtown Fish & Game Club is about 6 miles ahead on the right.
